

**ORDINANCE NO. 2023-O-04**

**ORDINANCE LEVYING AND ASSESSING TAXES OF  
DEERFIELD-BANNOCKBURN FIRE PROTECTION DISTRICT,  
LAKE COUNTY, ILLINOIS FOR 2023**

**BE IT ORDAINED** by the Board of Trustees of the Deerfield-Bannockburn Fire Protection District, Lake County, Illinois, as follows:

**Section One:** That the sum of **TWELVE MILLION, NINETY-TWO THOUSAND SEVEN HUNDRED DOLLARS AND NO CENTS (\$12,092,700.00)** be assessed and levied from and against all taxable property within the limits of the said Deerfield-Bannockburn Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2023, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

**CORPORATE FUND**

Corporate Fund Levy \$ 4,752,400.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

**AMBULANCE FUND**

Ambulance Fund Levy \$ 4,752,400.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

**FIREFIGHTER PENSION FUND**

Pension Fund Levy \$ 1,234,900.00

The foregoing amount is hereby levied for pension fund purposes pursuant to provisions of 40 ILCS 5/4-118.

**FIREFIGHTER PENSION FUND (P.A. 93-0689)**

Additional Pension Fund Levy (P.A. 93-0689) \$ 526,000.00

The foregoing amount is hereby levied for pension fund purposes pursuant to provisions of 40 ILCS 5/4-118 and exempt from PTELL by Public Act 93-0689.

**AUDIT FUND**

Audit Fund Levy \$ 15,000.00

The foregoing amount is levied for Audit Fund purposes pursuant to the provisions of 50 ILCS 310/9.

**TORT FUND**

Liability Insurance Fund Levy \$ 700,000.00

The foregoing amount is hereby levied for tort liability purposes pursuant to the provisions of 745 ILCS 10/9-107.

**SOCIAL SECURITY PROGRAM FUND**

Social Security Program Fund Levy \$ 22,000.00

The foregoing amount is hereby levied for social security insurance purposes pursuant to the provisions of 40 ILCS 5/21-110

**MEDICARE PROGRAM FUND**

Medicare Program Fund Levy \$ 90,000.00

The foregoing amount is hereby levied for Medicare program purposes pursuant to the provisions of 40 ILCS 5/21-110.1.
